

## Conditions of participation for EWM GmbH's competition

### 1. Participation

Only those persons from Europe, a minimum age of 18 years and a valid postal address in Germany may take part in this competition. Each person may only enter the competition once.

Competition participants must have an Internet connection and an e-mail address. The use of several Facebook accounts to increase the chances of winning is not permitted.

Employees of EWM GmbH and connected companies involved in organising the competition, including relatives of the aforementioned groups, are excluded from participation.

Participation is free of charge and independent of purchasing goods and services.

### 2. Disqualification from the competition

EWM AG reserves the right to exclude participants who violate the conditions of participation or try to influence the competition via technical manipulation. In the case of an exclusion from the competition, prizes may also be subsequently revoked and reclaimed.

### 3. Duration of the competition and draw
